**Subject: General Guidelines regarding certification of Electric instantaneous water heaters**

1. The following Indian Standards are published by ETD for the product 'Electric instantaneous water heaters':

Sl.No.	IS no.	Title	Scope	Remarks
a.	IS 8978 : 1992	Specification for electric instantaneous water heaters (Second Revision)	This standard covers general, safety and performance requirements of electric instantaneous water heaters up to 3 litres capacity for heating water to a temperature below boiling point.	The IS 8978 covers the safety requirements as per IS 302-2-35 and performance requirements of electric instantaneous water heaters
b.	IS 302 -2-35 : 2018	Safety of household and similar electrical appliances: Part 2 particular requirements: Sec 35 electric instantaneous water heaters (Second Revision)	This Indian Standard deals with the safety of electric instantaneous water heaters for household and similar purposes and intended for heating water below boiling temperature, their rated voltage being not more than 250 V for single-phase appliances and 480 V for other appliances.	The IS 302-2-35 covers the safety requirements for electric instantaneous water heaters

2. Department of Promotion of Industry and Internal Trade (DPIIT) has notified the product 'Appliances for electric instantaneous water heaters' as per IS 302-2-35 : 2018 for mandatory BIS certification under their Electrical Appliances for domestic water heating (Quality Control) Order, 2023. The last date of implementation of the QCO is 04 September 2024.
3. In this regard, following has been decided with respect to certification of electric instantaneous water heaters:
- a. Existing licencees as per IS 8978 may be allowed to changeover to get licence as per IS 302-2-35. In such case, licence as per IS 302-2-35 shall be granted for the varieties

already covered in the scope of existing licence as per IS 8978 without carrying out any further testing and inspection.

- b. In case the existing licensee as per IS 8978 wishes to continue their existing licence and apply for a separate licence as per IS 302-2-35, then the licence as per IS 302-2-35 shall be granted for the varieties already covered in the scope of existing licence as per IS 8978 without carrying out any further testing and inspection.

The Marking Fee applicable in such cases shall be as per **Note 2 of gazette notification Ref: CMD-2/G-18 dated 5<sup>th</sup> August 2021.**
