**Subject: Guidelines for Change in Scope of Licence (CSoL) and special situations as per the conformity assessment Scheme – X of Schedule – II of the BIS (Conformity Assessment) Regulations, 2018**

This document stipulates the guidelines for change in scope of licence (CSoL), its procedures and any special situations encountered during the operation of licence. These are to be read in conjunction with the BIS Act 2016 and Rules, Regulations framed thereunder. In particular, the provisions for CSoL are addressed in Regulation 9 and Paragraph 10 of Scheme - X of Schedule - II of the BIS (Conformity Assessment) Regulations, 2018, as amended from time to time. Any situation, in general, not covered in these guidelines are to be dealt as per the provisions of the Act, Rules and Regulations by the Regional Offices (ROs) and Branch Offices (BOs).

***Application  
for CSoL***

1. An application for change in scope of licence shall be made as per ***Annexure-I*** along with requisite fee and relevant documents.

***General  
Principles for  
CSoL***

2. The scope given in the schedule of licence covers types, sizes, grades, varieties, etc. for which licence is granted by the Bureau to licensee to use standard mark for the product manufactured in accordance with relevant specified requirement(s) mentioned in the schedule of licence. The change in scope of licence shall be endorsed as per ***Annexure-II***.
3. The provisions provided under grant of licence guidelines and all remaining relevant procedures regarding technical file(s)/ product compliance report(s)/ undertakings/ inspection visit / raw material etc. are to be followed (unless otherwise specified to deviate here in this document).

***Change of  
scope (with or  
without  
inspection  
visit)***

4. (i) If the application for change in scope of licence is accompanied with the technical file covering all aspects, including compliance report of product having complete test report issued by third party laboratory(ies), then based on desk assessment of the technical file the case may be processed for change in scope of licence.

(ii) In-principally, as far as feasible, the manufacturer shall submit product compliance report in the form of test report(s) issued by third party laboratory(ies), especially for the products where third party laboratory(ies) are available.

(iii) In the event of submission of partial technical file (including compliance report of product), the BO may seek clarification from the manufacturer and take decision for further processing based on reply from the manufacturer. The manufacturer shall furnish remaining details of the technical file (including compliance report of product).

(iv) In the event of submission of product compliance report having test report(s) issued by laboratory(ies) other than third party laboratory(ies), the applicable parameters can be witnessed through an inspection visit. The applicant may request for witnessing of these applicable tests by the certification officer during inspection visit, subject to:

- (a) Facilitating witnessing of applicable tests in the factory premises or any other site including sub-contracted test facilities
- (b) Payment of inspection fee for the visit
- (c) Availability of sufficient material for carrying out the applicable tests

***Inspection visit, where required***

5. Depending upon the product category and/or feasibility about the number of mandays required for witnessing the applicable test(s), the Head (BO) may decide to depute the certification officer(s) for inspection visit. The Head (BO) shall also decide the number of mandays required for inspection visit taking into account nature, complexity of product and time required to witness the test(s).

***Deficiencies***

6. (i) In case of any deficiencies observed in the application for change in scope of licence, the same shall be communicated to the manufacturer for providing information within 21 days. This communication shall include that in case reply is not received within 21 days or reply received is incomplete, the same shall be treated as rejection notice (Template enclosed as ***Annexure-III***).

(ii) The decision on rejection shall be taken based on the merit of the case.

(iii) In case, the application for change in scope of licence is rejected, the same shall be communicated to the manufacturer. (Template enclosed as ***Annexure-IV***)

***Reduction in scope of licence***

7. (i) If at any time, there is reason to reduce the scope of licence, a notice of one month shall be issued to the manufacturer. (Template enclosed as ***Annexure-V***)  
  
(ii) The change in scope of licence shall be informed (Template enclosed as ***Annexure-VI***) and endorsed as per ***Annexure-II***.  
  
(iii) The competent authority shall pass speaking orders for the decision taken.

***Special situations***

8. For any special situation arising during the operation of licence with regard to change of name, management, ownership etc., appropriate details with requisite documents as required at the time of grant of licence shall be collected. Such changes shall be duly endorsed in the licence. For guidance, following templates are enclosed
  - (i) Change in name of licensee; ***Annexure-VII***
  - (ii) Change in specified requirement(s); ***Annexure-VIII***

***Fees***

9. The fees for review of technical file for change in scope of licence is rupees twenty thousand per technical file. The fees for inspection, for any site as applicable, is rupees twenty thousand per manday.
