Subject: Utilisation of provisions for sharing of testing facilities – reg.

- 1) This has reference to the above.
- 2) More than 600 products have already been brought under compulsory BIS certification through different QCOs/technical regulations. QCOs for more products are being issued by various Ministries/Departments continually, due to which various sections of industry are being covered in the ambit of BIS certification, especially under Scheme-I (SI).
- 3) With reference to the requirement under Scheme-I for establishment of testing facilities and following levels of control, various industry sectors have requested BIS to consider permitting sharing of testing facilities.
- 4) In light of the growing ambit of BIS certification, in order to facilitate the industry and ease the process of certification, all Branch/Regional offices shall consider such requests sharing of testing facilities with a positive approach. Special consideration may be given for such requests received in case of products under compulsory certification.
- 5) Guidelines for permitting relaxation in testing facilities including for sharing of test facilities have already been published under Annex-X of the Guidelines for Grant of licence for Conformity Assessment Scheme-I available on BIS website. These guidelines shall be utilized effectively in such cases.
- 6) Furthermore, if in certain cases, the Head of the Branch Office is of the opinion that a particular case/situation is not explicitly addressed in the extant guidelines, or feels the need for an approach different from that given in the guidelines due to certain reasons, such cases, along with the recommendation of the BO, may be referred to DDG (Certification) through DDGR, for consideration of the matter.
- 7) All ROs/BOs shall take note of the above and ensure immediate compliance.
