Subject: Guidelines for implementation of Amendment No. 1 to IS 302-2-23: 2009

1. The product 'Electrical Appliances for Skin and Hair care' as per IS 302-2-23: 2009 'Safety of Household and Similar lectrical Appliances Part 2 Particular Requirements Section 23 Appliances for Skin or Hair Care' has been notified for mandatory certification under the Electrical Appliances for Skin or Hair care (Quality Control) Order, 2023. The last date of implementation of the QCO is 04<sup>th</sup> March 2025

- 2. ETD has published Amendment No. 1 to the IS 302-2-23 : 2009. The last date of implementation of Amendment No. 1 to the IS 302-2-23 : 2009 is 29<sup>th</sup> March 2025.
- 3. All the BOs shall inform the applicants and licencees of Appliances for Skin or Hair Care in their jurisdiction about implementation of Amendment No. 1 to the IS 302-2-23: 2009 within a week of issuance of these guidelines.
- 4. The significant changes brought through this revision as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amended Indian Standard.

- 5. Consequent upon the publication of the Amendment to the Standard and change in grouping guidelines, the Product Manual has been prepared as **PM/IS 302-2-23/3/November 2024** and made available on BIS website.
- 6. The guidelines for implementation of the Amendment No. 1 to the IS 302-2-23 : 2009 are given below:

#### **A.** For existing licencees:

- 7. All existing licencees as per existing IS 302-2-23: 2009 shall implement Amendment No. 1 to the IS 302-2-23: 2009 by 29<sup>th</sup> March 2025. Any difficulty in implementation shall be brought to the notice of CMD III within 30 days of issuance of these guidelines. BOs shall ensure that no Licences are under operation without implementation Amendment No. 1 to the IS 302-2-23: 2009 after 29<sup>th</sup> March 2025. The status of implementation of the Amendment No. 1 to the IS 302-2-23: 2009 shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.
- 8. For implementation of the Amendment, the existing licencee have to take following actions:
  - a) Submit copy of modified marking plate;
  - b) Submit copy of modified instruction manual;
  - c) Submit in-house/ independent test report for establishing compliance to the additional/ modified requirements of IS 302-2-23 : 2009 along with Amendment No. 1.
- 9. BO to review the existing scope of licence in view of the revised grouping guidelines and issue endorsement accordingly.
- 10. Verification of implementation of the Amendment to the Standard, shall be done during the next visit which shall be completed within one month from the date of submission of compliance by licensee.
- 11. If the Licensee fails to complete all actions by 29<sup>th</sup> March 2025 it shall be dealt with as per the prevailing guidelines.

### **B.** For New Applicants:

- 12. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without considering this Amendment. However, if the Applicant is desirous of considering the Application with the Amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the Amendment, the licence will not be granted without the Amendment.
- 13. Applications which are recorded henceforth may be processed with or without considering the Amendment. Processing of Applications without Amendment shall be permitted only up to 29<sup>th</sup> March 2025 and for such cases Applicant shall give a declaration that they will implement the Amendment by 29<sup>th</sup> March 2025.
- 14. Beyond 29<sup>th</sup> March 2025 no Licence shall be granted without consideration of the Amendment.

## C. For Change in Scope of Licence

15. For change in scope of licence, the relevant provisions as given above for Applicants shall

apply.

- 16. However, processing of such applications for change in scope of licence without considering the Amendment shall be permitted only upto the date of implementation of the Amendment by the licensee or up to 29<sup>th</sup> March 2025 whichever is earlier.
- 17. The above guidelines shall come into force with immediate effect.
