Subject: Guidelines for implementation of amendment no.1 to IS 73: 2013– Acetone

1. Amendment No. 3 to IS 170 :2022 has been published with last date of implementation as 21 October, 2024
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
Page 3, Table 1, SI No. (v), col (5)]	IS 1448 (Part 175) and (Part 182) added in addition to IS 2362 as referred test method for determination of water content
Inserted note below table 1, page 3	IS 2362 to be the referee method for determination of water content
Page 7, Annex E, clause E-4.2	The reference colour standard required for permanganate test has been modified to Cobaltous Chloride-Platinum Cobalt, Colour Standard Solution in place of existing cobalt (II) chloride and uranyl nitrate colour standard. The method of preparation of modified colour standard i.e. Cobaltous Chloride-Platinum Cobalt, Colour Standard Solution has also been specified.

3. Consequent upon the issuance of the amendment to Standard, the existing Product manual has been revised and is being circulated separately, through BIS website, as Product Manual Doc: PM/170/6/August 2024.

4. The guidelines for implementation of amendment 3 to the IS are as given below:

A. LICENSEES:

a) Any difficulty in implementation shall be brought to the notice of CMD-2 immediately after issuance of these guidelines. BO shall ensure that Licence is not under operation without consideration of amendment no 3 to the IS after 21 October, 2024. The status of implementation of the amendment shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of implementation.

b) Licensee is required to submit evidence of conformity through In-house/Independent Test Reports as well as revised declaration for additional testing chemical in Form no 2 as applicable. Verification of implementation of the amendments to the IS, shall be done through a surveillance visit preferably within 30 days of confirmation of implementation of the amendments to standard by licensee.

c) If the Licensee fails to complete all actions by 21 October, 2024, it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

a) Existing Applications for GOL where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the IS with/without the amendment. If the Applicant is desirous of considering the Application, with the amendment to the IS, a declaration may

be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the IS incorporating the amendment, Licence will not be granted by BIS without considering the amendment.

b) Applications which are recorded henceforth may be processed with or without considering Amendment no 3 to the IS. Processing of Applications without considering the amendment, shall be permitted only upto 20 October, 2024. For such cases Applicant shall give a declaration that they will implement the amendment by 21 October, 2024.

c) Beyond 21 October, 2024, no Licence shall be granted without considering the amendment.

C. CHANGE IN SCOPE OF LICENCE:

i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.

ii. However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto 21 October, 2024 whichever is earlier.

5. BOs are requested to circulate this amendment to all the licensees and applicants immediately within 7 days of issue of this circular.

6. The above guidelines shall come into force with immediate effect.
