Subject: Guidelines for implementation of revised Indian Standard IS 3623: 2024- Guide and Rubbing Ropes

1. IS 3623: 1978 has been revised and published as IS 3623: 2024. **The last date for implementation of the revised Standard is 06 Sep 2024.**
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised standard **within a week of issuance of these guidelines.**
3. The significant changes brought through this revision as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Sl. No.	Page No and Clause reference	Changes
1.	Page 1, Cl. 2	Referred Indian Standards (on definition and technical requirements) have been updated
2.	Page 5, Table 3- Regarding reverse bend test for round wire	Editorial corrections have been done for nominal wire of diameter 9.9 mm above

4. Consequent upon revision of the Standard, no change in manufacturing and testing facilities will be required for existing manufacturer licensees or applicants. Also, no evidence of conformity will be required to be submitted by the licensees, as compliance to the revision.
5. Consequent upon revision of the Standard, existing Product Manual has also been revised as Doc: PM/ IS 3623/2/ July 2024. In this revision, modifications has been done in grouping guidelines Scheme of Inspection and Testing.
