Subject: Guidelines for implementation of amendment no. 5 to IS 5149:2020 – MALEIC ANHYDRIDE, TECHNICAL

1. Amendment No. 5 to IS 5149 :2020 has been published with last date of implementation as 24 December, 2024

2. The significant changes in the standard though this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
clause A-3.1.3, line 1)	'Bloch' has been substituted by 'Block'
clause A-7.1.3, line 4	'agitating with a stirrer of platinum wire' has been substituted by 'agitate with stirrer of platinum wire/glass rod'

3. Since there are no changes in the requirement specified, no evidence of conformity for amendment no. 5 to the ISS is required to be submitted and no change in scope of the licence is required consequent to the implementation of this amendment.

4. BOs are requested to circulate this amendment to all the licensees and applicants immediately within 7 days of issue of this circular.

5. Consequent upon the issuance of the amendment to Standard, the existing Product manual has been revised and is being circulated separately, through BIS website, as Product Manual Doc: PM/5149/6/September 2024.
