- 1. Amendment No. 1 to IS 15225: 2002 has been published with last date of implementation as 07 January, 2025
- 2. The significant changes in the standard though this amendment as listed in the Table are given for the purpose of general guidance.

- 3. Through this amendment referred method of test for chlorine has been changed from IS 4669 to IS 15778/ISO 1158 as IS 4669 does not specifies any method of test for chlorine.
