Sub: Revision of product manual for Safety of Toys with respect to addition of new models in series already covered in licence

1. This has reference to the above.
2. BIS has received requests from the toy industry for simplification of the process of adding new models in the series already covered in licence, given that due to the dynamic nature of the toy industry/market, new models have to be introduced from time to time rapidly.
3. In this context, it has been decided that whenever a licensee intends to **add new models of toys in the series that are already covered in the scope of their licence**, they can submit a request through Manakonline and the information shall be noted by BIS and these additional models endorsed in the licence document by revising the Annexure to the licence document containing the series wise list of models (**such requests shall not be treated as requests for extension in scope**).
4. **After submission of the information to BIS Branch Office through Manakonline, the licensee may use the standard mark on toys with respect to such models without waiting for BIS to endorse the models in the licence.** However, in case any discrepancy is observed by BO post-facto due to which it is viewed that the models are not to be endorsed in the scope (e.g. if the models do not belong to the series as declared), Head of BIS Branch Office concerned, may, after giving the licensee an opportunity to explain, direct the licensee to cease marking on the toys of the relevant models, or in case the toys are already marked and dispatched, issue directions for product recall.
5. Based on the above, a modified product manual has been issued and hosted on BIS Website making necessary changes to this effect and introducing three appendices for declarations by applicant/licensee regarding application for grant of licence, change in scope (addition of new series) and addition of new models in the pre-existing series as per appendix-II, III and IV, respectively.
6. BOs are requested to kindly take note of the above for compliance and for circulation of this information to all licensees.
