Subject: Guidelines for implementation of revised IS 2556 (Part 15) : 2024 - 'Vitreous China Sanitary Appliances — Part 15 - Specific Requirements of Universal Water Closets'

- 1. IS 2556 (Part 15) : 2004 has been revised as IS 2556 (Part 15) : 2024 and has been published. The last date for implementation of the revised Standard is **29 November 2024** after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes in the revised Standard as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

- 4. Consequent upon the issuance of the revised Standard, existing Product Manual has been revised as Doc: **PM/IS 2556 (Pt 15)/2/July 2024**.
- 5. The guidelines for implementation of the revised Standard is given below:

### A. <u>LICENSEES</u>:

(i) No action is required by the existing licensees towards implementation of revised IS 2556 (Part 15) : 2024.

(ii) The earlier version of Standard does not cover the requirement of water efficiency rating and labelling. The scope of licence in the Product Manual has been revised to include additional requirement of water efficiency. BOs shall issue endorsement with the revised scope of licence as per the Product Manual.

(iii) Licensees who opts for Water Efficiency Rating, shall submit the declarations wrt the rating and labelling of water closets as per Clause 11 of IS 2556 (Part 15):2024. Provision of CSoL shall be followed to include Water Efficiency Rating of (i.e. 1 Star/ 2 Star/ 3 Star) in the scope of licence.

## B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto 29 Nov 2024 and for such cases, Applicant shall give a declaration that they will implement the revised Standard by 29 Nov 2024.
- (iii) Beyond **29 Nov 2024** no Licence shall be granted as per the old Standard.

# C. <u>CHANGE IN SCOPE OF LICENCE</u>:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto 29 Nov 2024 whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
