Subject: Extension of the last date of implementation of revised IS 302 (Part 2/Sec 3) : 2024/IEC 60335-2-3 : 2022

1. This has reference to the subject mentioned above.
2. The existing IS 302-2-3 : 2007 'Safety of household and similar electrical appliances Part 2 particular requirements Sec 3 electric iron (First Revision)' has been revised and published as IS 302 (Part 2/ Sec 3) : 2024/ IEC 60335-2-3 : 2022 'Household and Similar Electrical Appliances Safety Part 2 Particular Requirements Section 3 Electric Irons (Second Revision)'. The last date of concurrent running of both the Indian Standards was 23rd February 2025 after which the existing IS 302-2-3 : 2007 shall stand withdrawn.
3. The guidelines for implementation of the revised Indian Standard have been published vide our circular Ref: CMD III/16: IS 302 (Part 2/Sec 3) dated 10 Oct 2024.
4. The last date of implementation of IS 302 (Part 2/ Sec 3) : 2024/ IEC 60335-2-3 : 2022 has now been extended for one year upto 23rd February 2026. Other terms and conditions of CMD-III circular Ref: CMD III/16: IS 302 (Part 2/Sec 3) dated 10 Oct 2024 remains the same.
