IS 14183: 1994 PESTICIDE — CARTAP HYDROCHLORIDE SP — SPECIFICATION

[(Page 1, clause **5.1** (see also Amendment No. 1)] — Substitute the following for the existing clause :

'5.1 BIS Certification Marking

The product(s) conforming to the requirements of this standard may be certified as per the conformity assessment schemes under the provisions of the *Bureau of Indian Standards Act*, 2016 and the Rules and Regulations framed thereunder, and the products may be marked with the Standard Mark.'

[Page 2, Table 1, Sl No. (ii), col 2] — Substitute 'material insoluble in water, percent by mass (m/m), Max (see Note 1)' for 'material insoluble in water, percent by mass (m/m), Max'

[Page 2, Table 1, Sl No. (iii), col 2] — Substitute 'pH of 10 percent (m/m) extract (see Note 2)' for 'pH of 10 percent (m/m) extract, (see NOTE)'.

(Page 2, Table 1, Note) — Substitute the following for the existing NOTES:

- 1 Water shall be used instead of acetone as the solvent.
- **2** Cartap hydrochloride is very acidic and remains stable in acidic medium. It is hydrolyzed in neutral or alkaline medium so *pH* instead of acidity has been specified.'
