Subject: Guidelines for implementation of Amendment no. 2 to IS 17265: 2023 (Textiles - 100 Percent Polyester Spun Grey and White Yarns - Specification).

- 1. Amendment no. 2 to **IS 17265: 2023** has been published. The last date of implementation of the amendment is **05th March 2025**.
- 2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

Clause No.	Change
1	The scope has been modified (Dyed yarns and core spun yarn have been incorporated) and the following has been substituted for the existing: ' 1 Scope
	1.1 This standard specifies requirements for all types of 100 percent polyester spun single, double and multifold grey, white and dyed yarns including core spun yarn made from virgin and/or recycled polyester fibres.
	1.2 This standard doesn't specify requirements for fancy spun yarns such as slub yarn, thick and thin yarn, etc.'
6.4	The below Note has been added at the end: 'NOTE — The unevenness percentage and yarn imperfections shall be tested on cone type yarns.'
6.1,6.2,6.4	'6s Ne to up to 16s Ne (37 tex to 98 tex)' has been substituted by 'up to 16s Ne (37 tex or coarser)'.

- 3. Most of the changes to the standard through this amendment are editorial, none of which require any evidence of conformity to the amended standard to be established.
- 4. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
- No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after 05th March 2025.
- 6. The above guidelines come into force with immediate effect.
