# Subject: Guidelines for Testing of Pesticide Residues in Packaged Drinking Water as per IS 14543:2016 and Packaged Natural Mineral Water as per IS 13428:2005

- 1. This has reference to the subject mentioned above.
- It has been brought to the notice, that presently, laboratories usually carry out testing of pesticide residues (PR) for all FS and MS samples of Packaged Drinking Water as per IS 14543:2016 and Packaged Natural Mineral Water as per IS 13428:2005, due to lack of any specific instructions on the test requests.
- 3. Accordingly, taking cognizance of the above and considering the frequency of requirements of PR in the present SIT, it has been decided that henceforth, out of the samples drawn for factory/market surveillance in a year, only one sample may be got tested for pesticide residues.
- 4. The same shall be clearly indicated on the test requests generated by BOs/outsourced agencies. However, if a sample fails in the requirement of Pesticide Residues, then the next 3 consecutive samples (factory/market) of that licence shall be tested for all tests including Pesticide Residues(except Radioactive residues), till the 3 consecutive samples are found conforming to all requirements tested including pesticide residues.
- Hence, in the test requests for factory/market samples where pesticide residue is not required to be tested, the following shall be clearly mentioned: 'All tests/All Chemical tests/All Possible tests, except Pesticide Residues and Radioactive Residues'

And

where pesticide residue is required to be tested, the following shall be clearly mentioned: 'All tests/All Chemical tests/All Possible tests, including Pesticide Residues, but excluding Radioactive Residues'

- 5. All BOs are requested to take note of the above and ensure immediate compliance with immediate effect.
- 6. The above is issued with the approval of Competent Authority.
