Subject: Fixation of Marking Fee rates for Certification of Rubber Seals for Hydraulic Gates as per IS 11855:2017 (superseding IS 15466:2004)

1. This has reference to the subject mentioned above. The Indian Standard for Rubber Seals for Hydraulic Gates, IS 15466:2004 has been superseded by IS 11855:2017. IS 11855:2004 which is a code of practice Standard, is revised as IS 11855:2017 to include both the Product (IS 15466:2004) and the code of practice, under one Standard.
2. The Competent Authority has approved the Marking Fee rate for Rubber Seals for Hydraulic Gates as per IS 11855:2017 (superseding IS 15466:2004) as mentioned below. This Marking Fee rate is applicable with **immediate effect**.

3. BOs having licence for Rubber Seals for Hydraulic Gates as per IS 15466:2004 are advised to note the above for immediate compliance and take actions as given below:
 - a) All licensees/applicants to be informed about the fixation of marking fee.
 - b) Acceptance to MF rates as per IS 11855 : 2017 to be obtained.

The change over from IS 15466:2004 to IS 11855 : 2017 requires the acceptance to MF rate as per IS 11855 : 2017 only. After obtaining the acceptance to the Marking Fee, BOs shall immediately change over the licence from IS 15466:2004 to IS 11855 : 2017 and endorsement shall be issued accordingly.

4. The above guidelines come into force with immediate effect.
