Sub: Regarding use of non ISI marked HDPE/PP bags for packing sugar by Sugar Mills

1. This has reference to the above
2. High Density Polyethylene (HDPE)/ Polypropylene (PP) Woven Sacks for packaging 50 kilogram /25 kilogram Sugar as per IS 14968:2015 are under compulsory BIS certification as per the Textiles-High Density Polyethylene and Polypropylene woven sacks for packaging or filling (quality control) Order, 2020 issued by DCPC.
3. It has been brought to attention that many sugar mills in the country are using non ISI marked HDPE/PP bags for packaging sugar which is leading to a high level of burstage and loss of sugar to the Indian consumer. Letters have been sent to several sugar mills as per the attached list (**Annex-III**) as well as to the Indian Sugar Mills Association (ISMA) requesting for compliance to the provisions of the QCO and elaborating the penalties for violation of the QCO.
4. It has been decided that Branch Offices shall identify and contact the sugar mills in their areas to ascertain whether they are complying with the QCO and procuring only ISI marked HDPE/PP bags.
5. Accordingly, Heads of BIS Branch Offices are advised to arrange for sugar mills in their area to be identified and contacted and
 - a) An advisory may be issued to them to comply with the QCO and procure only ISI marked HDPE/PP bags for packing sugar and confirm that they are using ISI marked bags only. (Suggested format for the advisory is at **Annex-I**)
 - b) Those mills which confirm use of ISI marked HDPE/PP sacks or ISI marked jute bags for packing sugar may be visited and market samples may be drawn for testing.(Appropriate payment may be made where required for the same.)
 - c) Those mills which fail to confirm use of ISI marked HDPE/PP sacks may be investigated to ascertain if they are using non-ISI marked HDPE/PP sacks and if found doing so, appropriate action shall be initiated by the BO for violation of the QCO.

d) Following actions as above, a compliance report (for each sugar mill contacted) in the format as per **Annex-II** shall be sent as a doc/docx file to CMD-2 by email at cmd2@bis.gov.in by 31st January 2022.

e) This issues with the approval of Competent Authority.

Subject: Mandatory use of ISI marked HDPE/PP bags for packing sugar by Sugar Mills/Factories

Sir/Madam

Greetings on the New Year.

2. As you may be aware, the Government of India, in exercise of the powers of Section 16 of the Bureau of Indian Standards Act, 2016 (BIS Act, 2016) issues Quality Control Orders (QCOs) in the public interest or for the protection of human, animal or plant health, safety of the environment, or prevention of unfair trade practices, or national security making BIS certification compulsory for various products. At present, BIS certification has been made compulsory for more than 380 products.

3. In this context, your attention is drawn to the Quality Control Order issued by the Department of Chemical and Petrochemicals, Ministry of Chemicals and Fertilizers, making BIS certification compulsory for HDPE/PP Woven Sacks for packaging 50 kg/25 kg sugar as per the Indian Standard IS 14968:2015. A copy of this QC order is enclosed.

3. As per the provisions of the BIS Act, 2016, no person shall manufacture, import, distribute, sell, hire, lease, store or exhibit for sale any product(s) covered under the QCO without a Standard Mark (ISI mark) produced under a valid Licence. Any person who contravenes the provisions of the Order is liable to be punished with imprisonment for a term which may extend up to two years or with fine which shall not be less than two lakh rupees for the first contravention and not be less than five lakh rupees for the second and subsequent contraventions, but may extend up to ten times the value of goods or articles produced or sold or offered to be sold, under the provisions of sub-section (3) of section 29 of the BIS Act, 2016.

4. It is therefore requested to ensure that only ISI Marked HDPE/PP bags, manufactured by BIS licensed manufacturers, are used for packaging of sugar. At present, BIS has issued more than 45 licences to manufacturers of HDPE/PP Woven Sacks for packaging 50 kg/25 kg sugar as per the IS 14968:2015. You may access the list of licenses from www.manakonline.in (Click on Conformity Assessment (manakonline)>Search a licence>enter “14968” in the IS search box”)

5. **In case you are purchasing ISI marked HDPE/PP bags or ISI marked jute bags for packing sugar, it is requested to please inform the same to this office at the email address given below.** After receipt of your confirmation, BIS Officer may visit your premises for collection of samples of the ISI marked bags for testing. Suitable payment shall be made to you for the bags collected for testing. You are requested to please extend suitable cooperation and assistance to the officer.

6. It is also reiterated that storage of non-ISI marked HDPE/PP Woven Sacks for packaging 50 kg/25 kg sugar is also an offence under the BIS Act, 2016. **In case you are purchasing such non-ISI HDPE/PP bags, you are advised to cease the same and share the details of the sellers and manufacturers of these bags i.e. their names, complete addresses and contact numbers/email address with us immediately.**
