Subject: Amendment No.1 to Learning Science via Standards – SoP for Training of Science Teachers

Standard operating procedure for Training of Science Teachers under initiative Learning Science via Standards issued on 04 July 2023.

During the refreshers course organized by TNMD for Standard Promotion officers at NITS on 25-26 July 2024 and weekly meetings conducted by TNMD with SPOs and SPCOs; They have requested that the provision for reimbursement of local travel for participants attending the Mentor Training Program/Science Teacher Training Program under LSVS be incorporated into the respective guidelines.

In light of feedback received, Learning Science via Standards – SoP for Training of Science Teachers issued on 04 July 2023 is amended as follows for removing the constraints in providing reimbursement of local travel for participants attending the Science Teacher Training Program. Accordingly, the Standard operating procedure for Training of Science Teachers under initiative Learning Science via Standards issued on 04 July 2023 is amended as under:

Substitute the clause 4.2 (b) for the existing:

"Trainee participants may also be reimbursed travel expenses which shall be restricted to a maximum of AC 2 Tier train fare from the originating station to destination station or any by other admissible mode of travel, on production of original receipt(s) and/or invoice(s). For places not connected by train, reimbursement of bus fare, upto the limit of AC Bus by State Transport to be considered, subject to production of original bill/ ticket. Local Journeys from Residence/Temporary place of Stay/Venue to Airport/Station/Bus stop (To and Fro) shall also be reimbursed to participants as per entitlement for pay level in pay matrix 6 to 13 specified under Para D i) of Annexure of OM No. 19030/1/2017-E.IV dated 13 Jul 2017".

<u>Note:</u> The phrase 'Local Journey' shall be construed to mean journeys performed within the limits of suburban or other Municipalities, Notified Areas or Cantonments contiguous to the Municipality /Corporation of the town or city in which the duty point is located. Journeys within the limits of an urban agglomeration within which a Government Servant's headquarters are located will also be treated as 'local journey'.
