Subject: Amendment in BIS LRS – Relaxation in fee under LRS for MSME and women entrepreneurs and revision of fee structure under LRS.

1. The BIS laboratory recognition scheme has been formulated with the objective of having a sufficient number of outside laboratories in India and abroad, in addition to BIS labs to cater to the needs of various conformity assessment schemes of BIS. The main aim of recognizing laboratories under LRS is to support the conformity assessment schemes of BIS. With the introduction of various new products covered under QCOs and All India First Applications, the requirement of laboratories for testing of new products is increasing day by day and it is required to bring more laboratories in the fold of BIS and also the existing OSLs are getting their scope enhanced frequently.

2. In order to increase the number of laboratories under BIS LRS, the existing fees and charges under BIS LRS have been rationalized so that new laboratories are incentivized to apply for BIS recognition and also existing recognized laboratories can include more and more Indian Standards in their scope of BIS recognition. This will facilitate the coverage more and more industries in the ambit of the various BIS conformity assessment schemes of BIS by making available the required testing facility.

3. It has also been decided to reduce the recognition fee under BIS LRS for Rs. 1,00,000/- to Rs. 60,000/- for MSME and women entrepreneurs to support the laboratories established by MSME and women entrepreneurs. The inclusion application and processing fee has also been done away with in order to encourage laboratories for covering more and more Indian standards in their scope of BIS recognition.

4. The revised fee structure and delegation of power under BIS LRS 2020 is enclosed as revised **Annex-A & Annex-B** as approved by the competent authority.
