**Subject: Guidelines for implementation of amendment no. 1 to IS 16874: 2018 (Textiles - Protective gloves for firefighters – Specification).**

1. Amendment no. 1 to IS 16874: 2018 has been published. The last date of implementation of the amendment is **25<sup>th</sup> January 2025**.
  
2. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance.

<b>Clause No.</b>	<b>Change</b>
4.5	'IS 16258 for leather gloves (8.3 and 8.4 of IS 16258 shall not apply)' has been substituted by 'IS 582 (Part 9) for leather gloves'.
5.4.1	Typographical error has been corrected by substituting 'procedure F' for 'procedure E'.
Annex-A	'IS 16258 : 2015 (Leather — Chemical tests — Determination of pH)' has been deleted from the list of referred Indian Standards and simultaneously 'IS 582 (Part 9) : 2022 (Methods of chemical testing of leathers: Part 9 Determination of pH and difference figure)' has been inserted.

3. All the changes to the standard through this amendment are editorial, none of which require any evidence of conformity to the amended standard to be established.
  
4. In view of the above, BOs are requested to circulate this amendment to licensees and applicants immediately within 7 days of issue of this circular.
  
5. No application for grant of licence and/or change in scope of licence shall be accepted or grant of licence/change in scope permitted without consideration of the amendment after **25<sup>th</sup> January 2025**.
  
6. The above guidelines come into force with immediate effect.
