### **Subject: Guidelines for implementation of Revised IS 7898:2024 (Manually-Operated Chaff Cutter — Specification and Test Code)**

1. IS 7898:2001 and IS 1511:1979 have been amalgamated revised as IS 7898:2024 and has been published. The last date for implementation of the revised Standard is **22 Oct 2024** after which the old Standards shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause No.	Change
3	Requirements for materials of construction for components of the chaff cutter have been modified, and clause for hardness of blade along with reference to IS 1511 has been removed
4	Requirements for blade have been added in constructional requirements
5	Requirements regarding blade have been added under other requirements (requirement for blades to conform to IS 1511 has been removed)
8	Requirements regarding blade have been added under workmanship and finish
9.1	Thickness of blade has been added in marking requirements

4. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately through BIS website.
5. The guidelines for implementation of the revised Standard is given below:

#### **A. LICENSEES:**

- i. The licensee shall implement the revised Standard by **22 Oct 2024**. Any difficulty in implementation shall be brought to the notice of CMD 2 at the earliest. BOs shall ensure that no Licences are under operation as per the old Standard after **22 Oct 2024**. **The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-2 within two weeks of the last date of concurrent running.**
- ii. The licensee shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports as well as revised list of test equipment (as per Form 2). Verification of implementation of the revised Standard, wherever required, **shall be verified through a surveillance visit within 30 days of confirmation of implementation of the revised standard by licensee.**

- iii. If the Licensee fails to complete all actions by **22 Oct 2024** it shall be dealt with as per the prevailing guidelines.

**B. APPLICATIONS FOR GRANT OF LICENCE:**

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that if the sample fails while considering the provisions of the revised Standard, Licence will not be granted by BIS as per the old version.
- ii. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only up to **21 Oct 2024** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **22 Oct 2024**.
- iii. Beyond **22 Oct 2024** no Licence shall be granted as per the old Standard.

**C. CHANGE IN SCOPE OF LICENCE:**

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- ii. However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only up to the date of implementation of the revised Standard or up to **22 Oct 2024** whichever is earlier.

6. The above guidelines come into force with immediate effect.
