This is in continuation to earlier circulars of even number dated 17 May 2021 and 21 September 2021 on the subject cited above.

- 2) In this regard, guidance on the matter of deferment/expiry of licences w.r.t. 90 days time limit as per BIS (Conformity Assessment) Regulations, 2018 has been sought by various ROs/BOs.
- The ROs/BOs may kindly note that for the purpose of calculation of 90 days duration, the days of abeyance period starting from 17 May 2021 and ending on 30 September 2021 are not to be counted. This means the following:
 - i) For licences whose validity is between 17 May 2021 30 Sept 2021 (i.e. start and end date of abeyance period), 90 days period of deferment will start from 01 October 2021.
 - ii) For licences whose validity is before 17 May 2021, 90 days period of deferment will exclude the abeyance period.
