

2. All DDGRs are requested to conduct Essay Competition at the level of Regional Office concerned inviting entries for the Competition from the employees posted at BOs / Labs under their jurisdiction. Prizes to the winners of the Essay Competition may be given by the ROs, out of the funds allocated to the respective Regional Offices.

2.1 The DDGRs may kindly arrange to send a copy of the selected Essay winning the first prize to Vigilance Department by email/post. Out of the total Essays so received, one best Essay will be selected by Vigilance Department for publication in the 'Manak Darpan' magazine.

3. The employees posted at NITS under DDG(PRT) shall send their Essays directly to Vigilance Department. The employees posted at BOs/Labs under the jurisdiction of the Regional office concerned shall send their entries to the respective DDGRs **by 31.10.2022 positively**.

4. It may be noted that the Entries so submitted shall be original creation. In case, it is observed at any stage later that the entry is not original and/or copied, the same shall be summarily rejected by Vigilance Department. Decision of Vigilance Department will be final and binding and no correspondence whatsoever in this regard will be entertained.
