R/Sir,

I being the permanent resident of Ludhiana , Punjab would like to inform your good-self that the subjected factory located at the subjected address who subjected CML Number has been expired on 30-01-2024 and without renewing the said license of the subjected factory the owner of the factory is continuously running his factory and bulk production is being done with the marka on the tile as KHANNA and the subjected CML Number . The person/owner running the subjected factory is a government contractor whose name is Mr. Vishal Kaushal S/o Sh. Shiv Kumar Kaushal whose is at present residing at SAS Nagar, Mohali and his father Mr. Shiv Kumar Kaushal resides in the premises of the subjected factory.

The said person Mr. Vishal Kaushal being a government contractor had precured the tender of Approx. TWO CRORES of the road construction with 40mm and 80 mm of interlocking tiles /pavers of the Municipal Council, Khanna under the Department of Local

Government, Punjab. The tiles being manufactured in the subjected factory are continuous

being utilized and laid down in the construction work which is in progress. Daily heavy bulk

amount of interlocking tiles /pavers are being produced, dried and utilised at the sites of

the road to be constructed under Municipal Council, Khanna. The quality of the tiles being

produced the marka and cml number is the worst in quality and even the strength seems

to be very bad and it could be checked after the tiles are recovered and sent to the labs

for checking strength, camphor, density etc. Heavy chemical is being used in the factory

which as per the ISI rules is not to be used.

Now a days a construction of the roads in a private unauthorised colony is also in progress

where also the ISI mark consisting tiles are being used in bulk amount. The tile used in

construction of roads under the Municipal Limits of Khanna can be calculated after

obtaining the complete estimate and the copy of the work orders and the tender notification

list from the office of the Municipal Council, Khanna where the work of construction of

roads was started in the month of February 2024.

Hence it is requested that a raid/inspection must be done along with the technical team

without intimation to the subjected factory owner to know the exact position and the factory

creating production can be seen.
