Pl refer to our discussions yesterday in your office. We have attached guidelines for cancellation of R Number.

With regards to M/s Ganzhou Novel Battery Technology, China we wish to draw your attention that they have used standard mark (Model no 1260110 – 10,000Mah) of BIS pertaining to R 41140449 on lithium cells that are not registered (ie) Model no 1260110 – 9,000 Mah) when they exported to M/S Vizin India Pvt Ltd. It is pertinent to note that 1260110 with 10,000 Mah or 9,000 Mah look the same physically & visually and Vizin India Pvt Ltd who make power banks don't make 9,000 Mah power bank. This violates clause 3 of the above guidelines ' Using Standard Mark on unregistered goods' and hence liable for R Number cancellation.

Moreover Vizin India Pvt Ltd who makes power bank in India is also violating BIS guidelines by using 9000 Mah cells and making 10,000 Mah power bank and their R Number is also liable to be cancelled.

Similarly M/S. Brand Works Technologies Pvt Limited who makes power bank in India is also violating BIS guidelines by using 9000 Mah Cells and making 10,000 Mah Power bank and their R Number is also liable to be cancelled.

M/s Ganzhou Novel Battery Technology has another group company M/S Dongguan Novel Battery Technology Co. Ltd which is registered with BIS and have R Number 41048232. Being a group company with the same management their R Number should also be cancelled.

We are sure and confident Meity will ensure that low quality cells and deceitful practices are stopped in India.

Further to the below email pl find attached the import details of M/S Vizin India Pvt Ltd with respect to model no 1260110. This lithium cells have been imported from M/S Ganzhou Novel Battery Technology, China.

M/S Ganzhou Novel Battery Technology has registered with BIS R 41140449 lithium cell model 1260110 with 10,000 Mah capacity.

In the attached import details it is evident that M/S Ganzhou Novel Battery Technology exported with R 41140449 lithium cell model 1260110 with 9,000 Mah. The same is imported by M/S Vizin India Pvt Ltd to make power bank of 10,000 Mah and there are no power bank in India with 9,000 Mah capacity.

M/S Ganzhou Novel Battery Technology, China registered model 1260110 with 10,000 mah and using the same R Number exported 1260110 with 9,000 Mah violating BIS guidelines. This violation should be looked into strictly and the R Number 41140449 of M/S Ganzhou Novel Battery Technology should be cancelled as the import data proves the misuse of R Number.
