2. It is a single App that combines both Diary and Calendar and is available both in Android and iOS platform in their respective stores under name 'Gol Calendar'. The web version of Gol Calendar App will be available by 15th January, 2021 on url <https://www.goicalendar.gov.in>. Presently, this is available in Hindi and English which would be available in 11 other India languages by 15th of this Month. The Government of India Calendar App contains the following features:

- (i) Latest information on various schemes, events and publications of Government of India.
- (ii) Official holidays and various important dates.
- (iii) Inspirational and motivational messages from great personalities of our nation.
- (iv) Provision for taking notes digitally which will be stored with cutting edge security and privacy measures.
- (v) Provision for scheduling of meetings and setting reminders for important tasks and events.
- (vi) Accessibility features for visually impaired Divyangjans in coming days fulfilling the goal of Prime Minister's "Accessible India"/"Sugamya Bharat Abhiyan".

3. The Calendar has both Gregorian and Saka options available.

4. You may advise the officers and the staff of your Ministry as well as PSUs and other organizations under your Ministry to download the App on their Mobile phones/tablets.
