

Sir/Madam,

In pursuance of Section 28 of Bureau of Indian Standards Act, 2016, a search at the premises of M/s Rahul Gold House, No. 3/33, OMR Road, Kelambakkam, Chengalpattu District, Tamilnadu 603103 was undertaken at their premises on 12 Mar 2024. During the Search at M/s Rahul Gold House, they were found violating BIS Act 2016 by colourable imitation of BIS Hallmark – Without HUID. Hence the following materials were seized


