It has been observed that few Associations/Unions of BIS employees are operating at BIS Headquarters and few Regional Offices without obtaining formal recognition from the Competent Authority. All the service Associations/Unions of employees are required to obtain formal recognition under CCS (RSA) Rules, 1993 for considering their representations by the Competent Authority.

- The undersigned is directed to invite applications from existing and also newly formed/to be 2. formed Associations/Unions of BIS employees, who wish to seek recognition under the CCS [Recognition of Service Associations] Rules, 1993. Associations which have already obtained recognition are also required to submit fresh applications.
- The applications should be sent to this Department along-with the following documents by 07 3. June 2019.
 - i) Memorandum of Association/Union;
 - ii) Constitution of the Association/Union and bye-laws, if any;

iii) Names of the Office-bearers of the Association/Union;

iv) List of members [03 copies] duly signed by the authorized office bearer of the

Association/Union on each page of list.

Written Declaration addressed to Dir. [Estt.]/in respect of members of the v) Association/Union for Administration & Finance Cadre/Lab Cadre and to Head [HRD] in respect of Scientific Cadre for annual deduction of subscription from their July 2019 salary in favour of the Association/Union, strictly as per appended Annex I.

Applications received after the last date will not be entertained.

- The crucial month for verification under the check-off system will be July, 2019. That is, only such of the employees who have paid subscription from their July, 2019 salary (payable on the last working day of the month) will be treated as member of an Association/Union for verification purposes.
- The memberships of the Association/Union should be restricted to a distinct category of BIS Employees having common service interest. Unions/Associations would be recognized centrally in BIS, Headquarters. Such Unions/Associations may have their branches at ROs/BOs. The condition of minimum membership as laid down in Rule 5 (d) (i) of the said Rules is for the entire BIS. In other words, an Association/Union must have the minimum percentage of members amongst all employees in that distinct category/cadre in BIS.
