Committee informed that the Under Clause 3 RATING - It is not required to include the final temperature of the bus-bar, under condition of installation. The Rated current is included at clause 3.1 which in turn is related to temperature rise also. The Ambient temperature and Limits of Temp rise at various parts/surfaces are defined in Table 2.
