2. This material, violating the QCO, has been exported to India.

3. Further the Origin Mill has the BIS license for width ranging from 850mm to 1050mm while the exported material width (1170mm) is beyond the scope of BIS license.

4. In accordance, this consignment has dual-violations of QCO i.e.

a) Export of steel coils under QCO by Chinese mill with "Under Stop Marking" status

b) Export of material beyond the BIS licensed dimension.

5. Please note that this information has been obtained by us through our market sources.

6. We request the Government of India to take cognizance of this violation of QCO and take appropriate action according to the Indian laws and regulations.

7. In addition, we also request the Government of India to arrange for immediate corrective measures (on-line Digital solutions) to arrest such violations hereafter. Manual assessment should be done away in today's digital world.
