That the status as per BIS records, the status of Shree Radhey Helmets is under stop marking but the entity is still manufacturing false ISI mark helmets and Non ISI helmets from it's BIS registered address. That after conducting a market survey we visited the entity whereby it was seen manufacturing such faulty helmets.
