We are writing to bring to your attention the alarming issue of illegal imports of Polyester fiberfill as per IS 17263:2022, potentially without the Bureau of Indian Standards (BIS) Standard Mark and without BIS Licence into Chennai port thus violating the related QC Order for IS 17263.

These imports, often mislabeled with incorrect HSN codes such as Nylon, are primarily originating from China and Thailand.

This influx of unauthorised materials is causing significant confusion in the market and poses a threat to the integrity of products bearing the ISI mark, which are of Indian origin and comply with quality control orders as per IS 17263.

In particular, we urge you to investigate the importation details of the following suppliers whose details are given below::
