No production and nil stock of ISI mark product was found during visit. Firm has not manufactured ISI marked marine plywood since GOL. Stencil (method of marking) of licensee is also different from what is available in the photo uploaded by complainant. (Photo of stencil and dummy marking done by licensee also uploaded. The vendors KK veneer or Exotic Home décor are also not clients of the firm as stated by them.

2. **CONCLUSION:** The complaint could not be established at licensee end.

3. **RECOMMENDATIONS:** As complaint could not be established at licensee end, complaint end investigation may be carried out or it may be processed for closure as seen fit by competent authority.
