ITEM 0 GENERAL

0.1 Welcome by Head, Food & Agriculture Department, BIS

Shri Kuldeep Mittal, Member Secretary, FAD 1 extended a warm welcome to the Chairperson and members in the 22nd meeting of the Pesticides Sectional Committee, FAD 1. He thanked the Chairperson, Dr. J. P. Singh for his continuous and efficient guidance towards contribution to the national standardization work. Member Secretary also thanked all the members for their valuable inputs and cooperation and urged members to actively deliberate on the various issues in the agenda.

0.2 Opening Remarks by the Chairman

Dr. J. P. Singh, Chairperson, FAD 1 welcomed all the members of the Committee in its 22nd meeting. In his opening remarks, the Chairperson emphasized active participation of all members of the committee and urged them to deliberate on the various issues in the agenda in a pro-active and fruitful manner and respond within the stipulated time so that meaningful decisions could be taken and various draft standards finalized.

There being no comments, the committee confirmed the minutes of the 21st meeting of the Pesticides Sectional Committee, FAD 1 held online on 18 April 2024 circulated vide email dated 11 May 2024 without any modifications.

2.1 The Committee noted the scope and programme of work of FAD 1 as provided in Annex I of the agenda.


In the 20th meeting, the committee decided to circulate the above documents in wide circulation for a period of 60 days for public comments.

As per decision of the committee, the documents were issued in wide circulation for a period of 60 days.


