This has reference to Section 2.4.2 (17) of FOOD SAFETY AND STANDARDS (PROHIBITION AND RESTRICTIONS ON SALES) REGULATIONS, 2011 dated 01 August 2011.

Based on the complaint (complaint No. V-19127 dated 13/08/2024) received through Complaint Management System of Bureau of Indian Standards (BIS) against **M/s Aadvik Industries, VPO Kuthaiari, Tehsil Amb, Una, Himachal Pradesh** on **Violation of Quality Control Order (IS 14543)** a discreet investigation was carried out by BIS Parwanoo Branch Office to the factory premises of **M/s Aadvik Industries, VPO Kuthaiari, Tehsil Amb, Una, Himachal Pradesh** on 24/09/2024. During the discreet investigation, production was going on and stocks of Packaged Drinking Water were found available in the factory premises without BIS Standard (ISI) Mark.

This has reference to the complaint No. V-19127 dated 13/08/2024 received through Complaint Management System of Bureau of Indian Standards (BIS) against **M/s Aadvik Industries, VPO Kuthaiari, Tehsil Amb, Una, Himachal Pradesh on Violation of Quality Control Order (IS 14543).**

2. This is also with reference to Section 2.4.2 (17) of FOOD SAFETY AND STANDARDS (PROHIBITION AND RESTRICTIONS ON SALES) REGULATIONS, 2011 dated 01 August 2011.

3. A discreet investigation was carried out by BIS Parwanoo Branch Office on **24/09/2024** at the factory premises of M/s Aadvik Industries at VPO Kuthaiari, Tehsil Amb, Una, Himachal Pradesh to verify the activities of the firm under complaint.

4. During discreet visit, the following observations were made:


- (i) The firm under complaint was found open during the visit and production was going on.
- (ii) Stocks of Packaged Drinking Water filled in 1 Litre PET Bottles and 250 ml PET Bottles were available with following details: Name of the product: Non-carbonated Water Based Beverages, Date of Manufacturing: 23/09/2024, Batch No. B003, Expiry Date: 06 Month, Brand Name: Nature's Nectar having FSSAI License No. 1092401200044 with **NO BIS Standard Mark** (Discreet Investigation Report enclosed).

3. As per Section 2.4.2 (17) of FOOD SAFETY AND STANDARDS (PROHIBITION AND RESTRICTIONS ON SALES) REGULATIONS, 2011 dated 01 August 2011, no person shall manufacture, sell or exhibit for sale Packaged Drinking Water except under the Bureau of Indian Standards Certification Mark. Since, production was going on and stocks of Packaged Drinking Water were found available in the factory premises without BIS Standard (ISI) Mark during the discreet investigation dated 24.09.2024, this may be treated as violation of FSSAI Direction for compulsory use of BIS Standard Mark.

6. In view of the above, FSSAI may kindly look in to the matter and further actions may be taken as per prevailing Food Safety and Standards Act.



Following are the observations made during the discreet investigation:

1. The firm under complaint was found open during the visit and production was going on.
2. Stocks of Packaged Drinking Water filled in 1 Litre PET Bottles and 250 ml PET Bottles were available with following details: Name of the product: Non-carbonated Water Based Beverages, Date of Manufacturing: 23/09/2024, Batch No. B003, Expiry Date: 06 Month, Brand Name: Nature's Nectar with **NO BIS Standard Mark** (Photographs of Stock attached).
3. Hence, complaint against M/s **Aadvik Industries** for Violation of Quality Control Order (Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011) is established. In view of the above, Food Safety and Standard Authority of India (FSSAI) may be intimated for further necessary action.
