This has reference to the subject mentioned above.

- 2. The general guidelines for Grant of CoC have already been issued by CMD-I vide CMD-I/2:16:1 dated 02 may 2019 .
- 3. In this regard, the guidelines including documents for CoC for "Requirement of Retro-reflective Devices for Bicycles" as per Clause 4.14 of IS 10613: 2014 under Scheme-IV of BIS (Conformity Assessment) Regulations, 2018 are given below:
 - i) Product specific guidelines for Certificate of Conformity (CoC).
- ii) Inspection and Testing Plan for operation of the Scheme.
- iii) Letter to be sent to Distributors/ Dealers/ Sub-dealers by BOs.
- iv) Product specific application form and Self Evaluation cum- Verification Report.
- 4. The above guidelines shall come into force with immediate effect.

Guidelines for Certificate of Conformity (CoC) for

"Requirement of Retro-reflective Devices for Bicycles"

as per Clause 4.14 of IS 10613: 2014

under Scheme-IV of BIS (Conformity Assessment) Regulations, 2018

A. Guidelines for Grant of CoC

- 1. Application for Grant of CoC shall be processed on the basis of factory visit at the premises of the applicant (Bicycle Manufacturer).
- 2. During the visit, Factory Testing (FT) shall be done to verify the following:
 - i) Whether bicycles are equipped with ISI Marked Reflectors (either fitted or accompanied with).
 - ii) Conformance to the requirements of Cl. 4.14 of IS 10613:2014.
- 3. At least 5 packed boxes of reflectors, selected at random, shall be checked for General Requirements. One bicycle shall be fitted with the requisite reflectors and compliance to Cl. 4.14 of IS 10613 shall be verified. The results of FT shall be reported in Form A "Factory Test Report".
- 4. To ensure effective implementation of the QCO, it is necessary that bicycles are sold to end-users with requisite ISI Marked Reflectors as per the QCO, which has to be ensured by every Distributor/Dealer/Sub-dealer. For facilitating this, the broad responsibilities of Bicycle Manufacturers are:
 - (a) To provide the list of Distributors/ Dealers/ Sub-dealers etc. to BIS and facilitate sustained awareness programs for them to propagate the provisions of QCO.
 - (b) To communicate to Distributors/ Dealers/ Sub-dealers etc. w.r.t their responsibilities towards ensuring compliance of QCO, detailing the number of reflectors, color of reflectors etc. including necessary instructions to the effect that they shall display in local language at some prominent location in the bicycle shop indicating "As per Government directives, Bicycles are to be sold along with requisite number of ISI Marked Reflectors only".
 - (c) To submit an undertaking to BIS in Form B "Undertaking" to the above effect.
- 5. Grant of CoC shall be done based on satisfactory compliance of the above.

<u>Note</u>: Based on the list provided by Bicycle Manufacturers, BOs shall write to Distributors/ Dealers/ Sub-dealers to sensitize them on the QCO and to gear them up for its implementation (Letter attached).

C. Surveillance

(a) Visits at the premises of CoC holder

- 1. Surveillance visits shall be carried out at the premises of CoC holder. During the visits, the following shall be verified:
 - i) Records of purchase and consumption of ISI marked reflectors vis-à-vis the quantity of bicycles manufactured and dispatched.
 - ii) Records of testing as per Inspection and Testing Plan.
- iii) Whether bicycles are equipped with ISI Marked reflectors (either fitted or accompanied with).
- iv) Whether CoC No. marked on bicycle or package of bicycle.
- 2. At least 5 packed boxes of reflectors, selected at random, shall be checked for General Requirements. One bicycle shall be fitted with the requisite reflectors and compliance to Cl. 4.14 of IS 10613 shall be verified. The results of FT shall be reported in Form A "Factory Test Report".

(b) Market Surveillance

- 1. Market Surveillance shall be done at the premises of Distributor/ Dealer/ Sub-dealer to verify compliance of QCO.
- 2. During the Market Surveillance, it shall be verified if bicycles are equipped with ISI Marked reflectors (either fitted or accompanied with).
- 3. At least one packed box of reflectors or one bicycle fitted with reflectors, selected at random, shall be checked for General Requirements. The results of Market Surveillance shall be reported in Form C "Market Surveillance Report".

This has reference to the Bicycles-Retro Reflective Devices (Quality Control) Order, 2020, issued by Ministry of Commerce and Industry, Government of India., copy of which is attached. The order comes into force with effect from 01 Jan 2021.

As can be seen from the order, Bicycles should be fitted with the retro-reflecting devices (i.e reflectors), in accordance with Cl. 4.14 of the Indian Standard IS 10613 which specifies safety requirements for Bicycles). Copy of the relevant extract of the Standard is attached for your kind reference.

As per the above order, a Bicycle should be fitted with ISI Marked reflectors as per following detail:

All Bicycle manufacturers are required to obtain a Certificate of Conformity from BIS and sell the Bicycles under a valid CoC only.

As per the above QCO, it is violation of the QCO to sell Bicycles without the necessary reflectors as above. Any person who contravenes the provisions of the QCO, shall be punishable under the BIS Act, 2016.

In view of the above, you are therefore requested to comply with the above order.
