विषय: बीआईएस द्वारा भेजे गए नमूनों के लिए बीआईएस मान्यता प्राप्त बाहरी प्रयोगशालाओं हेतु ए परीक्षण शुल्क के निर्धारण की नीति ।

सक्षम प्राधिकारी ने बीआईएस द्वारा भेजे गए नमूनों के लिए बीआईएस मान्यता प्राप्त बाहरी प्रयोगशालाओं के लिए परीक्षण शुल्क के निर्धारण हेतु नीति का अनुमोदन किया है। इस नीति के साथ कार्यान्वयन के दिशा-निर्देश संलग्न है। बीआईएस की प्रयोगशालाएं अनुलग्नक 1 में अपनी स्वीकृति प्राप्त करने के लिए अपने अधिकार क्षेत्र के अंतर्गत कार्यरत बाहरी प्रयोगशालाओं को नीति परिचालित करेगा और कार्यान्वयन दिशानिर्देश के अनुसार बीआईएस मान्यता प्राप्त बाहरी प्रयोगशालाओं के परीक्षण शुल्क को तय करने के लिए अन्य कदम उठाएगा।

Implementation guidelines for policy on fixation of testing charges for BIS recognized OSLs.

- This policy is applicable only to samples sent by BIS and will not be applicable for the samples sent directly by the manufacturers.
- No upward revision of testing charges by OSL will be permitted due to the policy of BIS on capping the upper limit of testing charges. The BIS testing charges will only act as the upper cap.
- All the BIS recognized OSLs will be required to submit their acceptance of BIS policy towards the testing charges (Annex 1) and provide their testing charges with breakup of individual test requirements within 30 days to the respective BIS Laboratories.
- 4. The testing charges submitted by the OSLs will be reviewed by respective BIS Labs and the testing charges will be fixed for two years which can be revised after completion of two year period. This exercise is to be completed by 15th September 2018 and revised testing charges shall be effective by 16th September 2018.
- 5. Wherever, testing charges are not available either in BIS labs or in BIS recognized Govt. labs or in case of any aberrations in fixing the upper limit of testing charges. BIS would decide the upper limit of testing charges for such products. In such cases a committee with below constitution will decide the upper limit of testing charges on a consultative basis:
 - a) DDGL Chairman.
 - b) Head CMD-1
 - c) Head CMD-2
 - c) Head CMD-3
 - d) Representative from Finance Department
 - e) Head LPPD.
 - f) Representatives from two OSL recognized for the IS under consideration
 - g) Member Secretary from LPPD.
- 6. In cases where additional test requirements are added in the standard through revision/amendment, the OSLs will submit their proposal for additional testing charges for the new test requirements .BIS will consider and approve the testing charges for the new requirements uniformly for all OSLs.

Policy on fixation of testing charges for BIS recognized OSLs for the samples sent by BIS

- a. BIS recognized labs can have their own testing charges. However, for BIS samples the testing charges shall not exceed one & half times (1.5) the testing charges of BIS labs wherever these are available.
- b. Wherever BIS testing charges are not available, the testing charges of BIS recognized Government labs (excluding CPRI wherever applicable) for those products would be considered and the average of such testing charges for that product would be worked out by BIS. For BIS samples the testing charges shall not exceed 1.5 times the testing charges as calculated above.
- c. In case of specialized labs which are being utilized by BIS for testing of samples and are categorized as Group 2 laboratories, testing charges shall not be regulated. CPRI labs, though recognized by BIS shall also be treated at par with these specialized labs for the purpose of testing charges.
- d. Wherever, testing charges are not available either in BIS labs or in BIS recognized Govt. labs or in case of any aberrations in fixing the upper limit of testing charges, BIS would decide the upper limit of testing charges for such products.
- e. The testing charges for outside recognised laboratory during the tenure of the recognition shall be declared and fixed at the time of its recognition for two years. The testing charges shall remain fixed for the duration of the recognition of two years. There shall be no upward shall remain fixed for the duration of the recognition except when the standard is revised/amendment issued.
- f. BIS may also consider revision of testing charges of OSLs on WPI (Wholesale price index) basis wherever the BIS testing charges have not been revised for a period more than 2 years

Annex 1.

Policy on fixation of testing charges for BIS recognized OSLs for the samples sent by BIS

- a. BIS recognized labs can have their own testing charges. However, for BIS samples the testing charges shall not exceed one & half times (1.5) the testing charges of BIS labs wherever these are available.
- b. Wherever BIS testing charges are not available, the testing charges of BIS recognized Government labs (excluding CPRI wherever applicable) for those products would be considered and the average of such testing charges for that product would be worked out by BIS. There shall be no upward revision in the testing charges during the period of recognition except when the standard is revised/amendment issued.
- f. BIS may also consider revision of testing charges of OSLs on WPI (Wholesale price index) basis wherever the BIS testing charges have not been revised for a period more than 2 years

The above policy is acceptable to us and we will provide our testing charges for the IS in our scope of recognition with breakup of individual test requirements within 30 days to BIS.
