I want to complain about jewelry shop in Delhi which is allegedly selling gold articles with fake hallmark . This is as per the information received from one of their employees. I request that this be thoroughly investigated and action initiated under the Bureau of Indian Standards Act, 2016, against this jewellery shop. The shop details are below:

SHREE RAM JEWELLERS, GST Number: 07BDAPB5747H1ZR
Address: 1ST FLOOR PLOT NO 2704/16, SHOP NO 8, SARAFA BAZZAR, BANK STREET, AJMAL KHAN ROAD, KAROL BAGH, Central Delhi, Delhi, 110005 . GST details are attached.

Previously also, one of their other shops in Fazilka in Punjab was raided against complaint no. H18473 and they were found selling gold jewellery without halmark.

I request that this be properly investigated and strict action taken.
