Subject: Guidelines for implementation of Amendment No. 02 to IS 3818: 1992 'Continuous (Piano) hinges'.

- 1. Amendment No. 02 to IS 3818 : 1992 has been published. The last date for implementation of the amendment is 04 October 2018.
- 2. All BOs shall inform the Applicants/Licensees under their jurisdiction about implementation of the above amendment.
- 3. The significant changes in the amendment as listed in the Table is for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

4	Tolerance on actual pin diameter specified

- 4. Existing STI is modified as SIT Doc: SIT/3818/1, JULY 2018.
- 5. The guidelines for implementation of the amendment is given below:

A. For Licensees:

- (i) All Licensees shall implement the amendment by **04/10/2018**. BOs shall ensure that no Licences are under operation as per IS 3818: 1992 without the amendment after **04/10/2018**.
- (ii) Licensees shall confirm conformance to the additional requirements through In-house/ Independent Test Reports or Test Certificates, as applicable. Verification of additional requirements and facilities, if any, may be done during the next visit.
- (iii) In case of non-implementation of the amendment by **04/10/2018**, necessary actions may be initiated.

B. For Applicants:

- (i) Existing Applications where Sample has been submitted in the Laboratory/the Laboratory has issued Test Report may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in new test requirements, BIS will not grant Licence as per the old version.
- (ii) Applications, which are recorded henceforth, may be processed with or without consideration of the amendment. Processing of Applications without consideration of the

amendment shall be permitted only upto 04/10/2018 and for such cases; Applicant shall give a declaration that they will implement the amendment by 04/10/2018.

(iii) Beyond **04/10/2018** no Licence shall be granted without consideration of the amendment.

C. For Inclusions:

- (i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of Inclusions without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto **04/10/2018** whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
