### **Subject: Guidelines for implementation of Amendment No. 1 to IS 10889:2004 - High Density Polyethylene Films**

1. Amendment No. 1 to IS 10889:2004 has been published. The last date for implementation of the amendment is **5 June 2019**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment **within a week of issuance of these guidelines**.
3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

6.1.4.1	The formula for calculation of density of base material has been corrected by inserting parentheses at the required places. (Typographical correction)

4. There are no changes in the existing STI.
5. The guidelines for implementation of the amendment is given below:

#### **A. LICENSEES:**

- (i) All Licensees shall implement the amendment by **5 June 2019**. BOs shall ensure that no Licences are under operation as per IS 10889:2015 without the amendment after **5 June 2019**.

#### **B. APPLICATIONS FOR GRANT OF LICENCE/CHANGE IN SCOPE:**

- (i) No Licence shall be granted/ no change in scope permitted, without consideration of the amendment henceforth.
6. The above guidelines come into force with immediate effect.
