- 2. The following grouping guidelines have been approved by the Competent Authority for considering grant of licence/change in scope of licence for the above product:

### **Grouping guidelines for IS 5557 Part 2:2018**

1. As Per IS 5557 Part 2:2018, All Rubber Gum Boots and Ankle Boots Have Been Classified in Following three Varieties:

Variety	Classification II
1.	For use in Areas having Contact with oil and Grease.
2.	For use in fire and explosives prone Area.
3.	For Use in General Working Conditions.

- 2. In Addition above Standard covers following types, designs and sizes:
  - i) Types: Type 1-Ankle Boots; Type-2-Wellington/Gum Boots
  - ii) Design-B,C,D,E (refer fig. 1, 2 and cl. 8.3 of IS 5557 Part 2:2018)

- c) \*\*\*If the Applicant /Licensee applies for two or more Design, testing to be done for each Design separately.
- d) \*\*\*\*Samples of any size can be taken for considering other sizes in the same group, however manufacturing and testing facility for each size must be verified.
- 4. However, while considering grant of licence/inclusion of additional sizes/designs/varieties/types, it will be ensured that the applicant/licensee has got the complete manufacturing and testing facilities for all the sizes and designs intended to be covered.
- 5. During operation of the licence, BO will ensure that all the sizes/designs/varieties/types covered in the licensee are tested in Rotation. The above guidelines may be followed for grant of licensee as well as inclusion of new Variety.
- 6. The above grouping guidelines come into force with immediate effect.
