Subject: Guidelines for implementation of IS/IEC 60730-2-9 : 2011

1. IS/IEC 60730-2-9 : 2011 and has been published, superseding IS 3017: 1985. The last date for implementation of the revised Standard is 8 July 2019 after which IS 3017: 1985 shall stand withdrawn.
2. IS/IEC 60730-2-9 : 2011 covers all Automatic electrical temperature sensing controls used in household appliances including thermostats for use with refrigerators, air-conditioners, water heaters, ovens etc. It contains many new tests like Heating, Manufacturing deviation and drift, Environmental stress, EMC- Emission and Immunity, Components, Normal and Abnormal operations etc. which were earlier not covered in IS 3017: 1985.
3. All BOs shall inform the Applicants and Licensees under their jurisdiction about the implementation of IS/IEC 60730-2-9 : 2011.
4. The existing STI for IS 3017: 1985 has been replaced by Scheme of Inspection and Testing (SIT) Doc: SIT/60730-2-9 /1 Aug 2018.
5. The guidelines for implementation of IS/IEC 60730-2-9 : 2011 is given below:

A. For Licensees:

- (i) All Licensees shall switchover to the revised Standard by 8 July 2019. BOs shall ensure that no Licences are under operation as per the old Standard after 8 July 2019.
- (ii) Licensees shall confirm conformance to the applicable additional/modified requirements through In-house/ Independent Test Reports or Test Certificates, as applicable. Verification of additional requirements and facilities, if any, may be done during the next visit.
- (iii) If the Licensee fails to complete all actions by 8 July 2019, necessary actions may be initiated.

B. For Applicants:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration from the Applicant may be obtained to that effect and the Application may be processed accordingly. An undertaking from such Applicants shall also be obtained that if the sample fails in new test requirements, Licence will not be granted by BIS as per the old version.

(ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per old Standard shall be permitted only upto 8 July 2019 and for such cases Applicant shall give a declaration that they will switchover to revised Standard by 8 July 2019.

(iii) Beyond 8 July 2019 no Licence shall be granted as per the old Standard.

C. For Inclusions:

(i) For Inclusion of New Varieties, the relevant provisions as given above for Applicants shall apply.

(ii) However, processing of Inclusions as per the old Standard shall be permitted only upto the date of switchover to the revised Standard or upto 8 July 2019 whichever is earlier.

6. The above guidelines come into force with immediate effect.
