# Subject: Grouping guidelines for certification of Refrigerators with or without low temperature compartment as per IS 1476 (Part 1): 2000.

1. The parameters given below shall be considered for grouping of refrigerators as per IS 1476 (Part 1): 2000 for GoL/CSoL:

Type of Refrigeration	Mechanical
	Vapour absorption

- 2. Refrigerator having largest Rated Total Storage Volume for each type shall be tested to cover the range of refrigerators of that particular type in the scope.
- 3. The Firm shall declare the type and Rated Total Storage Volumes of refrigerators intended to be covered in the Licence. The Scope of Licence may be restricted based on the Manufacturing and Testing capabilities of the Manufacturer.
- 4. During the operation of the Licence, BO shall ensure that all the refrigerators covered in the Licence are tested in rotation, to the extent possible.
