**Subject: Guidelines for Implementation of Amendment No. 2 to IS 5672 : 1992, Specification for Mineral Mixtures for Supplementing Poultry Feeds.**

1. Amendment No. 2 to IS 5672 : 1992 has been published. The last date for implementation of the amendment is **02 December 2020**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment **within a week of issuance of these guidelines**.
3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause 2.1	IS No. 13574 : 1992 Animal feed and feeding stuffs- Determination of calcium and magnesium in mineral supplements has been deleted and the following new ISS have been specified for testing of calcium:  IS 13433 (Part1) : 1992 Animal feed and feeding stuffs- Determination of calcium: part 1 Titrimetric method or IS 15121 : 2002/ISO 6869 : 2000 Animal feeding stuffs- Determination of the contents calcium, copper, iron, magnesium, manganese, potassium, sodium and zinc - Method using atomic absorption spectrometry.
Table 1, Sl. No. ii), col 4	Substitute IS 15121 or 13433 (Part 1) for IS 13574 : 1992.
Table 1	Insert the following at the end of the table: “In case of dispute, the method given in IS 15121 shall be the referee method”.

4. Product Manual incorporating Amendment No. 2 to IS 5672 : 1992 was issued on vide CMD-2/G-73/16: 5672 dated 29 05 2020. There are no changes in the existing PM/SIT.

5. The guidelines for implementation of the amendment is given below:

**A. LICENSEE:**

(i) All licensees shall implement the amendment by **02 December 2020**. BOs shall ensure that no Licences are under operation as per IS 5672 : 1992 without the amendment after **02 December 2020**. **The status of implementation of the amendment shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of concurrent running.**

**B. APPLICATIONS FOR GRANT OF LICENCE:**

(i) Existing Application where sample has been submitted in the Laboratory/Test Report has been issued by the laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.

(ii) Applications which are recorded henceforth shall be processed with or without consideration of the amendment. Processing of Application without consideration of the amendment shall be permitted only up to **02 December 2020** and for such cases Applicant shall give a declaration that they will implement the amendment by **02 December 2020**.

(iii) Beyond **01 December 2020**, no Licence shall be granted without consideration of the amendment.

6. The above guidelines come into force with immediate effect.
