Subject: Guidelines for implementation of Amendment No. 1 to IS 14490:2018 (Plain Copier Paper)

1. Amendment No. 1 to IS 14490:2018 has been published. The amendment shall be implemented with effect from **2 Sept 2020**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment **within a week of issuance of these guidelines**.
3. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause	Requirement
5.3, first sentence	Plain Copier Paper of 90 g per square metre grammage has been added in the scope of the Indian Standard
Annex B	Recommendation for raw materials and its source have been provided for guidance purpose

4. There are no changes in the existing SIT.
5. The guidelines for implementation of the amendment is given below:

A. LICENSEES:

- (i) All Licensees shall implement the amendment by **2 Sept 2020**.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly.
- (ii) Applications which are recorded henceforth may be processed with or without consideration of the amendment. Processing of Applications without consideration of the amendment shall be permitted only up to **1 Sept 2020** and for such cases Applicant shall give a declaration that they will implement the amendment by **2 Sept 2020**.
- (iii) Beyond **2 Sept 2020** no Licence shall be granted without consideration of the amendment.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence without consideration of the amendment shall be permitted only upto the date of implementation of the amendment by the licensee or upto **2 Sept 2020** whichever is earlier.

6. The above guidelines come into force with immediate effect.

**IS 14490 : 2018 PLAIN COPIER PAPER —
SPECIFICATION**

(*First Revision*)

(Page 1, clause 5.3, first sentence) — Substitute the following for the existing sentence:

‘The grammage (substance) of plain copier paper shall be either of 70 g per square metre or 75 g per square metre or 80 g per square metre or 90 g per square metre, when tested as per IS 1060 (Part 5/Sec 5).’

(Page 3, Annex A) — Insert the following new annex after Annex A:

‘ANNEX B

(*foreword, fifth para, fourth sentence*)

**RECOMMENDATION FOR RAW MATERIALS AND ITS SOURCE
(FOR GUIDANCE ONLY)**

✓ **‘B-1** To reduce the load on natural forest and to meet the need of raw material for making of pulp and paper; the alternate sources of fibrous natural substrate is also recommended. Thus, the following raw material are also recommended for manufacturing of plain copier paper which may be obtained from sources as given below:

- a) Fibrous raw materials wood / bamboo sourced from Social Farm Forestry or State Forest Corporations or pulp procured with FSC conformity.
- b) Non wood fibre sources from agro residues such as bagasse, wheat straw, sarkanda or similar products
- c) Recycled paper sources such as white cuttings / cleaned deinked pulp.’
