Subject: Guidelines for testing of samples of Microfine Ordinary Portland Cement as per IS 16993 : 2018.

This has reference to the subject mentioned above.

As testing of Ordinary Portland Cement as per IS 269 : 2015 and Microfine Ordinary Portland Cement as per IS 16993 : 2018 is similar in larger extent except for Particle size and Bleeding test, the guidelines given below shall be followed for testing of samples:

(a) Samples shall be sent to BIS laboratory (where test facility as per IS 269 : 2015 is available) for testing of all parameters except Particle size and Bleeding test.

(b) Separate sample shall be sent to BIS approved laboratory for testing Particle size and Bleeding test till such time BIS labs have these facilities.

All BOs shall ensure immediate compliance to the above plan for testing of samples and also shall clearly indicate the applicable tests in the test request, before sending samples to laboratory.
