**Subject: Guidelines for implementation of Amendment No. 1 to IS 5557 (Part 2):2018 (All Rubber Gum Boots and Ankle Boots Part 2 Occupational Purposes)**

1. Amendment No. 1 to IS 5557 (Part 2):2018 has been published. The amendment shall be implemented with effect from **2 Dec 2020**.
2. All BOs shall inform the Applicants under their jurisdiction about implementation of the above amendment **within a week of issuance of these guidelines**.
3. The significant changes in the standard through this amendment as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

<b>Clause</b>	<b>Requirement</b>
7.7, para 1	Requirement for material of insocks has been changed
11.2, para 1 and 11.3	BIS Certification marking clause has been modified
12 (e)	The requirement to mark "Time Period of Obsolescence" on the boots has been removed

4. There are no changes in the existing SIT.
5. Applicants may be informed of the same and implementation of the amendment ensured within the last date.
6. The above guidelines come into force with immediate effect.

AND ANKLE BOOTS  
PART 2 OCCUPATIONAL PURPOSES**

(Page 4, clause 7.7, para 1) — Substitute 'In-socks shall be made out of rubber/polymer/elastomer compound with non-woven nylon fabric as top covering' for the existing.


(Page 6, clause 11.2, para 1) — Substitute the following for the existing.


'The product(s) conforming to the requirements of this standard may be certified as per the conformity assessment schemes under the provisions of the *Bureau of Indian Standards Act, 2016* and the Rules and Regulations framed thereunder, and the products may be marked with the Standard Mark.

All markings shall be made inside of tongue or at top outer face of the boot so that least damage is done during working.'

(Page 6, clause 11.3) — Delete.

[Page 5, clause 12 (e)] — Delete and renumber subsequent entries.
