Subject: Guidelines for implementation of Revised IS 9873 (Part 3):2020 (Safety of Toys Part 3 Migration of Certain Elements)

- 1. IS 9873 (Part 3):2017 has been revised as IS 9873 (Part 3):2020 and has been published. The last date for implementation of the revised Standard is **27 June 2021** after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

Clause	Change
9.7	Two detailed dewaxing methods have been introduced to replace the original one
10.1	An ICP-OES method for determination of elements has been given in Annex C for reference

4. The major changes in revised IS 9873 (Part 3):2020 are as under:

- 5. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately.
- 6. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

- i. All Licensees shall implement the revised Standard 27 June 2021. BOs shall ensure that no Licences are under operation as per the old Standard after 27 June 2021.
- ii. Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports (In house test report or independent test report for any one model of toy covered in licence indicating conformity to IS 9873 (Part 3):2020 may be accepted for this purpose). Verification of implementation of the revised Standard, wherever required, may be done during the next visit.
- iii. If the Licensee fails to complete all actions by 27 June 2021 it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- i. Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard (i.e. considering IS 9873 (Part 3):2020 as the applicable secondary standard), a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- ii. Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard (i.e. considering IS 9873 (Part 3):2020 as the applicable secondary standard). Processing of Applications as per the old Standard shall be permitted only upto 26 June 2021 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 27 June 2021.
- iii. Beyond 27 June 2021 no Licence shall be granted as per the old Standard (i.e. considering IS 9873 (Part 3):2017 as the applicable secondary standard).

C. <u>CHANGE IN SCOPE OF LICENCE</u>:

- i. For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- ii. However, processing of such applications for change in scope of licence as per the old Standard (i.e. considering IS 9873 (Part 3):2017 as the applicable secondary standard) shall be permitted only upto the date of implementation of the revised Standard or upto 27 June 2021 whichever is earlier.
- 7. The above guidelines come into force with immediate effect.
