Subject: Guidelines for Implementation of Amendment No. 4 to IS 2052 : 2009, Specification for Compounded Feeds for Cattle.

1. Amendment No. 4 to IS 2052 : 2009 has been published. The last date for implementation of the amendment is **18 April 2021**.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the above amendment **within a week of issuance of these guidelines**.
3. The significant changes in the amendment as listed in the Table is given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the amendment.

Clause no.	Requirement
Clause 3.1	Type III Cattle feed has been removed from the scope of Indian Standard.
Clause 4.2, Ingredients Clause 4.2.3 Clause 4.2.4	Following new clauses have been added: “Any material of animal origin except milk and milk products shall not be used as ingredient for manufacturing the product” has been added. Aflatoxin B1 content in solvent extracted rice bran as livestock feed and whole grains has been permitted upto 50 ppb.
Clause 4.3 & Table 1	The limits of requirements of crude fat and acid insoluble ash have been made more stringent. Minimum requirement of Crude fat for Type II has been increased from 2.5 to 3.0 percent by mass. Maximum requirement of acid insoluble ash has also been decreased from 3.0 to 2.5 % by mass for Type I and 4.0 to 3.0 % by mass for Type II.

4. Consequent upon issuance of the amendment, existing product manual incorporating SIT has been revised which is being circulated separately.
5. The guidelines for implementation of the amendment is given below:

A. LICENSEE:

- (i) All licensees shall implement the amendment by **18 April 2021**. BOs shall ensure that no Licences are under operation as per IS 2052 : 2009 without the amendment after **18 April 2021**.

The status of implementation of the amendment shall be confirmed by Head (BO) to CMD-II within two weeks of the last date of concurrent running.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Application where sample has been submitted in the Laboratory/Test Report has been issued by the laboratory may be processed without consideration of the amendment. However, if the Applicant is desirous of considering the amendment, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails while considering the provisions of the amendment, Licence will not be granted as per the old version.
 - (ii) Applications which are recorded henceforth shall be processed with or without consideration of the amendment. Processing of Application without consideration of the amendment shall be permitted only up to **18 April 2021** and for such cases Applicant shall give a declaration that they will implement the amendment by **18 April 2021**.
 - (iii) Beyond **17 April 2021**, no Licence shall be granted without consideration of the amendment.
6. The above guidelines come into force with immediate effect.
