Subject: Guidelines for implementation of Revised IS 517:2020 (Methanol (Methyl Alcohol))

- 1. IS 517:1986 has been revised as IS 517:2020 and has been published. The last date for implementation of the revised Standard is **18 April 2021** after which the old Standard shall stand withdrawn.
- 2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within a week of issuance of these guidelines.
- 3. The significant changes in the revised Standard as listed in the Table aregiven for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

4.3, 4.4 and 7.1, C-3	Alternate test methods for aldehyde and ketone have been added

- 4. Consequent upon the issuance of the revised Standard, the existing product manual has been revised which is being circulated separately.
- 5. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

- (i) All Licensees shall implement the revised Standard **18 April 2021**. BOs shall ensure that no Licencesare under operation as per the old Standard after **18 April 2021**.
- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house/Independent Test Reports or Test Certificates, as applicable. Verification of implementation of the revised Standard, wherever required, may be done during the next visit.
- (iii) If the Licensee fails to complete all actions by **18 April 2021** it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

(i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the Application as per the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may

- be processed accordingly. An undertaking shall from such Applicants also be obtained that in new test requirements, Licence will not be granted by BIS as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or the revised Standard. Processing of Applications as per the old Standard shall be permitted only upto **17 April 2021** and for such cases Applicant shall give a declaration that they will implement the revised Standard by **18 April 2021**.
- (iii) Beyond 18 April 2021 no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per the old Standard shall be permitted only upto the date of implementation of the revised Standard or upto **18 April 2021** whichever is earlier.
- 6. The above guidelines come into force with immediate effect.
