Subject: Guidelines for implementation of revised IS 11552: 2020- Liquid Nitrogen Vessels of Capacity up to 75 Litres

1. IS 11552: 2008 has been revised as IS 11552: 2020 and has been published. The last date for implementation of the revised Standard is 15 Aug 2021 after which the old Standard shall stand withdrawn.
2. All BOs shall inform the Applicants and Licensees under their jurisdiction about implementation of the revised Standard within **a week of issuance of these guidelines**.
3. The significant changes in the revised Standard as listed in the Table are given for the purpose of general guidance. BOs shall ensure that the product conforms to all the requirements, as applicable, as per the revised Standard.

4. BOs may also note that due to an existing error in the revised Standard at second sentence of Cl. 11.4.2, the existing text *“If these three vessels are found satisfactory in performance testing, a fresh batch of ten vessels shall be manufactured and tested as above”* is being replaced with **“If one or more of these three vessels are not found satisfactory in performance testing, a fresh batch of ten vessels shall be manufactured and tested as above and all of them shall meet the requirements”** through an amendment being processed by MED. BOs may take note of the above and also inform the licensees/applicants about the same.
5. Consequent upon issuance of the revised Standard, existing Product Manual has been revised as Doc: PM/IS 11552/2/June 2021. In this revision of product manual, year of the Standard and the number of amendments have been updated.
6. The guidelines for implementation of the revised Standard is given below:

A. LICENSEES:

- (i) All Licensees shall implement the revised Standard by 15 Aug 2021. Any difficulty in implementation shall be brought to the notice of CMD III at the earliest but in any case at least 30 days before the last date of implementation. BOs shall ensure that no Licences are under operation as per old Standard after 15 Aug 2021. **The status of implementation of the revised Standard shall be confirmed by Head (BO) to CMD-III within two weeks of the last date of concurrent running.**

- (ii) Licensees shall submit evidence of conformity to the additional/modified requirements through In-house Test Reports. Verification of implementation of the revised Standard, wherever required, may be done during the next visit **which may normally be completed within six months of the last date of concurrent running**.
- (iii) If the Licensee fails to complete all actions by 15 Aug 2021 it shall be dealt with as per the prevailing guidelines.

B. APPLICATIONS FOR GRANT OF LICENCE:

- (i) Existing Applications where Sample has been submitted in the Laboratory/Test Report has been issued by the Laboratory may be processed as per the old Standard. However, if the Applicant is desirous of considering the revised Standard, a declaration may be obtained from the Applicant to that effect and the Application may be processed accordingly. An undertaking shall also be obtained from such Applicants that if the sample fails in the new test requirements, Licence will not be granted as per the old version.
- (ii) Applications which are recorded henceforth may be processed as per the old Standard or revised Standard. Processing of Applications as per the old Standard shall be permitted only up to 15 Aug 2021 and for such cases Applicant shall give a declaration that they will implement the revised Standard by 15 Aug 2021.
- (iii) Beyond 15 Aug 2021 no Licence shall be granted as per the old Standard.

C. CHANGE IN SCOPE OF LICENCE:

- (i) For change in scope of licence, the relevant provisions as given above for Applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per Old Standard shall be permitted only upto the date of implementation of the revised Standard by the licensee or up to 15 Aug 2021 whichever is earlier.

7. The above guidelines come into force with immediate effect.
